

## DONGBU STEEL CO., LTD. REGULAR POLYESTER COATINGS WARRANTY OF DURABILITY (THE "WARRANTY ") (P7F302B, P3A793B, P1D703B, P1D712B, P6C832B, P5C912B, P8B272B, P6D664B)

DONGBU STEEL CO., LTD. (hereinafter called "DONGBU STEEL") warrants to AS TOODE (Dongbu reference #:FE1204091 01 ~ 08, 0.45 MM X 1250MM). (hereinafter called the "PURCHASER") that the surface coated with POLYESTER paint (the "Paint") on Hot Dipped galvanized steel sheet in coil supplied by DONGBU STEEL (the "Product") will meet the following exterior durability standards :

The Paint on the Products which are installed or used by the Purchaser at an incline of not more than  $75^{\circ}$  from the vertical, a period of ten (10) years from the date of shipment from the Republic of Korea :

- A. Will not chalk in excess of the ASTM-D-659 number six(6) rating as determined by the procedure outlined in ASTM-D-659;
- B. Will not fade more than the number of 10E (Hunter) units as determined by the procedure outlined in ASTM-D-2244 and based on the color measurements made on clean surfaces free of all dirt, chalk, oxidized film, oil, grease or other foreign contaminants; provided, however, that fading or color changes may not by uniform between surfaces not equally exposed; and
- C. Will not crack, check, peel, flake or chip to an extent that is apparent on ordinary outdoor visual observation; provided, however, that any cracks, breaks or other defects in the Paint occurring during forming, installing or fabrication of the Products shall not be covered by this Warranty.

## THIS WARRANTY SHALL BE SUBJECT TO STIPULATIONS AND CONDITIONS HEREINAFTER SET FORTH:

- 1. The exclusive and remedy under this Warranty shall be, at the sole discretion of DONGBU STEEL, to (i) repaint the Products; or (ii) provide, free of charge, replacements (but not installation) for the Products with defective Paint; or (iii) reimburse the cost of such repainting or replacement by the PURCHASER; provided, however, that the amount of such reimbursement shall in no event exceed the original purchase price of the Product;
- 2. Any repainted or replaced Products shall be subject to this Warranty only for the unexpired period of Warranty applicable to the original Products;
- DONGBU STEEL shall not in any event be liable for the cost of labour expended by others on any Products with defective Paint unless otherwise specifically authorized in writing by DONGBU STEEL prior to the performance of any such work;
- 4. DONGBU STEEL shall not in any event be liable for any special, indirect or consequential damages to anyone due to the Products with defective Paint;
- 5. DONGBU STEEL extends this Warranty solely to the PURCHASER. This Warranty is nontransferable and non-assignable. The PURCHASER or its agents or representatives shall not claim, represent or imply, nor permit its customer, distributors, applicators, contractors or any other person to claim, represent or imply, that this Warranty extends or is available to parties
